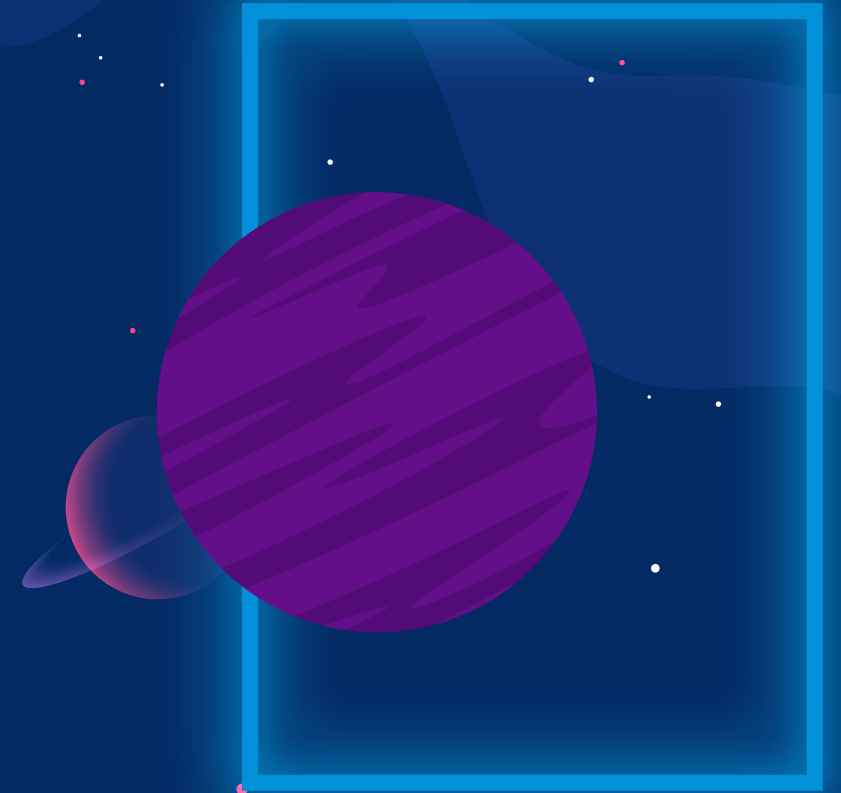

Developing an idea or prototype

Obtain SR&ED or introduction to angel investors

Refining value proposition and determining what makes you better

Identifying your target market and your product-market fit
