CAPTIAL

- At our CFO x Scaleup CEO C-Council meeting, leaders stressed: raise before you need to.
 Defensive capital strategies work best when you're not already in crisis mode.
- At our Indigenous-Led Tech Council meeting, we heard that mentorship must walk alongside the capital. Investment without guidance risks stalling progress before it begins.
- At our Startup CEO C-Council meeting, members shared that grants are valuable—but come with strings. Chasing funding that doesn't align with your core business can cost more than it gives.

CUSTOMERS

- At our CMO C-Council meeting, members were reminded that IP rights aren't just legal technicalities—they're business essentials. Lock down your contracts early to avoid growth roadblocks.
- At our SaaS CTO C-Council meeting, we learned that outsourcing only works when partners feel like part of the team. Clear scopes and strong relationships make the difference.
- At the Al x In-House Counsel C-Council meeting, the risk of Al hallucinations sparked debate.

 Fact-checking Al-generated outputs is now a customer trust issue—not just an internal concern.

TALENT

- At our Talent C-Council meeting, immigration uncertainty is reshaping how companies support global teams. Flexible work models and safety-first policies are gaining traction.
- At our Sustainability x Digital Health C-Council meeting, we heard that Al doesn't replace people—it elevates them. Teams are reaching higher-value work faster by automating routine tasks.
- At our CFO C-Council meeting, we heard that uncertainty isn't the problem—indecision is.
 Building plans around worst-case scenarios lets teams act with confidence, not hesitation.
