# TOP TIPS

## PART 1

### Be Strategic and Follow the Rules

#### **Aim high**

Consider applying for more than one category. One aligned to your size or stage and one where your unique story can stand out.

#### **Submit a complete application**

Follow the criteria closely as stated for your award category. Avoid reframing or skipping parts of the questions.

#### **Respect the process**

Stay within the word count. Judges only read up to the limit.

Don't wait until the last minute to send in your application. Ensure you plan time for revision and approvals!

# TOP TIPS

## PART 2

### Lead With Clarity, Impact and Authenticity

#### **Engage leadership**

The strongest applications reflect active CEO or founder involvement. This means engaging leadership early to identify the key messages and priorities and having them provide their input on the final application

#### **Tell an honest story**

Do not airbrush challenges. Judges value credible, authentic journeys, especially when tackling complex problems.

#### **Make it clear**

Explain what you do and why it matters in plain language. If a non-technical reader can understand it, you are on the right track.

#### **Check out the competition**

Review the previous years' finalists and winners to get a gauge on what made them stand-out from the crowd.

# TOP TIPS

## PART 3

### Show, Don't Tell

#### **Anchor your story in data**

Use numbers to back-up your statement. Growth rates, revenue impact, customer adoption and performance metrics matter.


#### **Use customer feedback to validate your impact**

Top-scoring applications do not rely on self-assessment alone. They include clear, attributable customer quotes to demonstrate their impact.

#### **Emphasize your story, not the market potential**

For Startup & Growth Companies: make sure to show traction and why you will win, not just market potential.

For Scale and Anchor Companies: revenue matters, but so does your investment in BC's talent, jobs, and ecosystem. Tell us about the legacy you are building!

---

Nominees in this category must be:

- Revenue of \$1M to \$10M
- Employees of 10 to 50
- Selling a technology-related product, service, solution, system or platform
- BC-based

COMPANY OF THE YEAR

SCALE

## About this Award

---

This award acknowledges a scaleup success tech company that is an emerging leader and role model in the BC technology industry. Winners of this award will likely continue to grow to become the next anchors of BC's tech ecosystem.

## Who Should Apply?

---

Nominees in this category must be:

- Revenue of \$10M to \$50M
- Employees of 50 to 200
- Selling a technology-related product, service, solution, system or platform
- BC-based

ANCHOR

## About this Award

---

This award acknowledges a company that is an established leader in the BC technology industry. Winners of this award exemplify financial, strategic, and product or service excellence, and are widely recognized as anchors of BC's tech ecosystem.

## Who Should Apply?

---

Nominees in this category must be:

- Revenue of \$50M+
- More than five years old and have 200+ employees
- Selling a technology-related product, service, solution, system or platform
- BC-based

---

This award celebrates a company of any size that epitomizes the ambition of BC's tech sector. Nominees in this category must be:

- Selling a technology-related product, service, solution, system or platform


